STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF UNSTARRED QUESTION NO. 3403 BY SHRI SATYADEV PACHAURI, SHRI DINESH CHANDRA YADAV AND SHRI RAJIV RANJAN SINGH ALIAS LALAN SINGH TO BE ANSWERED IN LOK SABHA ON 23.03.2022 REGARDING RAILWAY FREIGHT CORRIDOR.

(a) and (b): Presently, Ministry of Railways is implementing two Dedicated Freight Corridors namely, Eastern Dedicated Freight Corridor (EDFC) from Ludhiana to Sonnagar (1337 Km) and Western Dedicated Freight Corridor (WDFC) from Dadri to Jawaharlal Nehru Port Trust (1506 km.). Sonnagar-Dankuni (538 km) is being planned on PPP mode. Currently, 1110 km out of 2843 km of Dedicated Freight Corridor (DFC) has been completed. The Capital Expenditure (CAPEX) incurred in these Corridors till date is as under:-

(c) and (d): The progress of these projects suffered serious setbacks due to several factors including huge delays in land acquisition, delays in environment/forest clearances from State Governments, court cases, law and order problems and adverse impact of Covid-19 pandemic/lock downs and contract related issues. However, several proactive measures have been taken to fast track the project such as hike in fund allocation, close monitoring, resolution of contractual issues, resolving land acquisition issues and State Government related matters etc., besides other steps. The additional amount likely to be spent in these Projects due to delays can be ascertained properly only after full completion of the project.
