(b) whether it is also true that 65 geographical areas are spread over 215 districts in 19 States and one Union territory and if so, the details thereof;

(c) whether it is also a fact that in the latest gas bidding round, one oil marketing firm in public sector and one private firm were found to be bidders; and

(d) if so, the details thereof?

(a) to (d) Petroleum and Natural Gas Regulatory Board (PNGRB) had launched 11<sup>th</sup> City Gas Distribution (CGD) Bidding Round on 17<sup>th</sup> September, 2021 for development of CGD Network in 65 Geographical Areas (GAs) spread over 215 districts (212 complete and 3 part) in 19 States and one Union Territory. For 61 GAs, a total of 439 bids were received from 26 entities which include public sector and private sector bidders. List of bidders participated in the 11<sup>th</sup> CGD bidding round is at Annexure.

PNGRB has authorized 40 GAs and issued Letters of Intent (LoIs) for 21 GAs. As per assessment by PNGRB, investment of more than Rs. 80,000 crores is likely to be made by the authorized entities in the next 8-10 years.
