- (e) if so, the details thereof including the funds allocated to the projects in Uttar Pradesh during the last three years?**

National Capital Region Planning Board (NCRPB) has stated that the draft Regional Plan-2041 has been approved in 41st meeting of NCR Planning Board held on 12.10.2021 and has been published for inviting public objections and suggestions on 09.12.2021 as per Section 12 of NCRPB Act, 1985.**

**(c)to(e): NCRPB does not undertake/implement any project/scheme but only provides loan based financial support for the projects of the NCR participating States and their implementing agencies. The details of the major transport projects financed during the last five years is annexed. No new proposal has been received from Uttar Pradesh seeking financial support for transport or road projects.**
