(a): The Detailed Project Report (DPR) for setting up of Common Facility Centre (CFC) for Vizianagaram Gold Jewelry Cluster was submitted under the Scheme of Fund for Regeneration of Traditional Industries (SFURTI) of Ministry of Micro, Small and Medium Enterprises (MSME). The Nodal Agency and Implementing Agency for the project is Foundation for MSME Clusters and Sri Vishwakarma Gold Ornaments Manufacturers (Goldsmiths) Industrial Cooperative Society Limited, Vizianagaram respectively.

(b): The proposal of Vizianagaram Gold Jewelry Cluster was approved in the 33rd Scheme Steering Committee (SSC) Meeting of SFURTI held on 20.03.2020. The cost approved for establishing Common Facility Centre (CFC) under SFURTI for various components/ interventions of the said project is detailed at Annexure-I.
