- (a) whether the Government has made provisions for funds in the coming year for work relating to city development in Nanded, Maharashtra;**
- (b) if so, the details thereof;**
- (c) if not, the reasons therefor;**
- (d) whether any proposal for the above said work in Nanded has been sought from the State Government;**
- (e) if so, the details thereof; and**
- (f) if not, the reasons therefor?**

- (a) to (f) Urban Development is a State subject. Ministry of Housing and Urban Affairs (MoHUA) assists the States / Union Territories (UTs) in urban development through its Missions / Schemes- Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0, Smart Cities Mission (SCM), Swachh Bharat Mission-Urban (SBM-U) 2.0, Pradhan Mantri Awas Yojana-Urban (PMAY-U) and schemes under Urban Transport. Nanded is covered under AMRUT and PMAY-U. The status of the works taken up under these Missions is given in Annexure.**

**Annexure referred to in reply to part (a) to (f) of Lok Sabha Unstarred Question No 3636 regarding 'Funds for development of city in Maharashtra' for answer on 24 March, 2022**

**(i) Atal Mission for Rejuvenation and Urban Transformation(AMRUT)**

**2.0**

**Government of Maharashtra has taken up a water supply project costing ₹ 24.18 crore and three projects of green spaces and parks costing ₹ 4.5 crore in Nanded Waghala under AMRUT. The water supply project has been completed and projects relating to green spaces are under implementation. Government has launched AMRUT 2.0 on 1<sup>st</sup> October 2021 with the objective of providing universal coverage of water supply in all statutory towns in the country and universal coverage of sewerage & septage management in 500 AMRUT cities. Nanded is also covered under AMRUT 2.0. So far, under AMRUT 2.0, the operational guidelines of the Mission have been issued and representatives of States / Urban Local Bodies (ULBs) & other stakeholders have been trained in preparation of City Water Balance Plan (CWBP), City Water Action Plan (CWAP) and subsequently State Water Action Plan (SWAP).**

**(ii) Pradhan Mantri Awas Yojana-Urban(PMAY-U)**

**MoHUA under the vision of 'Housing for All' supplements the efforts of the States / Uts by providing Central Assistance (CA) for construction of houses for eligible families. CA amounting to ₹ 177.09 crore has been sanctioned against proposals for construction of 10,977 houses in Nanded of which ₹ 92.73 crore has been released. 8,018 houses have been grounded for construction. Of these 4,569 houses have been completed / delivered. Additionally, 6,458 houses of earlier JnNURM scheme were also grounded and completed since inception of PMAY-U.**
