BUDGETARY ALLOCATION TO ANGANWADI CENTRES

DR. KALANIDHI VEERASWAMY:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of Anganwadi Centres across the country, State/UT-wise including Tamil Nadu;
- (b) the details of facilities being provided through such centres;
- (c) the details of annual budgetary allocation to Anganwadi Centres during the last five years, state/UT-wise;
- (d) whether the Government conducts audit of all the Centres annually and if so, the details thereof particularly with regard to Odisha;
- (e) whether the Government has any proposal to set up more Anganwadi Centres and for upgradation of existing centres in the country; and
- (f) if so, the details thereof indicating the targets and time line fixed and funds required, State/UT-wise including Tamil Nadu especially in Nagapattinam district?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT

- (a) State/UT-wise number of Anganwadi Centres across the country including Tamil Nadu is at Annexure-I.
- (b) Under Anganwadi Services Scheme, the package of following six services is provided to the beneficiaries through a network of 13.89 lakh operational Anganwadi Centres across the country:
 - i. Supplementary Nutrition (SNP)
 - ii. Pre-school Non-formal Education,
 - iii. Nutrition & Health Education,
 - iv. Immunization,
 - v. Health Check-up, and
 - vi. Referral Services

Three of the six services, viz., Immunization, Health check-up and Referral Services are related to health and are provided through NRHM & Public Health Infrastructure.

(c) State/UT-wise budgetary allocation under Anganwadi Services Scheme during the last 5 years is at Annexure-II.

(d) The Scheme is implemented by the State Governments/UT Administrations and conducting the audit of Anganwadi Centres rests with the States/UTs, however, implementation and utilization of funds by the States/UTs is monitored by way of obtaining Physical Progress Reports/Utilization Certificates/Statement of Expenditure/Quarterly Progress Progress and also by capturing the data on Poshan Tracker.

(e) & (f) Anganwadi Services Scheme is a universal scheme and all the 14 lakh Anganwadi Centres have been sanctioned to all States/UTs. Recently Anganwadi Services Scheme has been revised and subsumed under Saksham Anganwadi and Poshan 2.0. Strengthening and upgrading of anganwadis is envisaged under the revised Scheme.
