- (c) whether the Master Plan for all PCPIR has been finalized and each PCPIR is having their active management board members;
- (d) if so, the details thereof; and
- (e) if not, the reasons therefor?

An area of about 23,000 Hectares of land covered in 45 villages in Cuddalore and Nagapattinam Districts were declared as "Local Planning Area" for the proposed PCPIR, vide Govt G.O. (Ms) No.108, H&UDD, Dated 20.06.2017. Government of Tamilnadu has cancelled the declaration of "local Planning Area" vide Govt G.O. (Ms) No 36, H&UDD, Dated 21.02.2020 and the same has been published in Tamil Nadu Govt., Gazette dated 21.02.2020.
