TREATMENT OF POOR CANCER PATIENTS

3767. SHRI MALOOK NAGAR:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of funds allocated and the number of cancer patients treated as a result of the utilization of the funds by various States/UTs, State/UT/district-wise; and
- (b) the details of funds allocated to hospitals for the treatment of poor cancer patients under the Bijnor Parliamentary Constituency in Uttar Pradesh and the number of patients benefitted therefrom?

ANSWER

(a) and (b): Health is a state subject. The Department of Health & Family Welfare, Government of India, however, provides technical and financial support to the States/UTs under the National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Diseases and Stroke (NPCDCS), as part of National Health Mission (NHM), based on the proposals received from the States/UTs and subject to the resource envelope. Cancer is an integral part of NPCDCS. The State/UT wise details of approvals under NPCDCS under Flexible Pool for Non-Communicable Diseases programme (NCD) under NHM during the last three years i.e. from the FY 2018-19 to 2020-21 is given at Annexure. As reported by State Government, Bijnor District in Uttar Pradesh has received Rs. 121.66 lakhs in the Financial Year of 2021-22 under NPCDCS Program.

Cancer patients are getting treatment at various health facilities in the health care delivery system including Medical Colleges, Central Institutes like AIIMS and private sector hospitals. Relevant data related to patients, including cancer patients, registered and under treatment, is maintained by the Institutions and Hospitals concerned at their own level.
