FUNDS ALLOCATED UNDER NHM IN CHHATTISGARH

3870. SHRI SUNIL KUMAR SONI:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to State:

- (a) the total amount of funds allocated to Chhattisgarh under the National Health Mission (NHM) since its inception, year-wise;
- (b) the total amount of funds allocated and spent in various districts of Chhattisgarh under NHM, district-wise;
- (c) whether the funds allocated under NHM are being utilized in Chhattisgarh as per the timelines drawn, if so, the details thereof and if not, the reasons therefor; and
- (d) whether the Government proposes to conduct audit of the funds spent and utilized under NHM in Chhattisgarh and if so, the details thereof and if not, the reasons therefor?

(a) to (d): National Health Mission (NHM) is a Centrally Sponsored Scheme under which the Government of India provides financial and technical support to States/UTs to strengthen their health care systems.

The details of funds released Centrally under National Health Mission (NHM) to the State of Chhattisgarh, since its inception, year-wise is at Annexure-IA.

District-wise details of funds released and expenditure under NHM since its inception, as reported by the State of Chhattisgarh is at Annexure-IB.

Under NHM, to improve the financial utilization of funds the following steps have been taken by the Ministry:

- (i) Performance Audit by the Comptroller and Auditor General (CAG) of India,
- (ii) Annual Statutory Audits by CAG empaneled major Chartered Accountant Audit firms,
- (iii) Concurrent Audits by Chartered Accountant Audit firms,
- (iv) Public Financial Management System (PFMS) in NHM to track flow of funds,
- (v) Submission of quarterly Financial Monitoring Reports (FMRs) and Statement of Fund Position (SFP) by the States/UTs,
- (vi) Review and monitoring of scheme components.
