PROVISION OF AMENITIES UNDER ADARSH SMARAK SCHEME

Will the Minister of Culture be pleased to state:

- (a) the details of amenities to be provided under the Adarsh Smarak Scheme along with the progress made thereunder;
- (b) the list of protected Government monuments under this particularly in Gujarat;
- (c) whether the Government proposes further inclusion and expansion of new tourist places under this scheme;
- (d) if so, the details thereof; and
- (e) if not, the reasons therefor?

ANSWER

- (a) Archaeological Survey of India (ASI) has identified 100 Centrally Protected Monuments (CPM) as “Adarsh Smarak” for upgradation of existing tourist facilities/amenities like drinking water, toilets, pathways, ramps, Wi-Fi, cafeteria, interpretation centre, brail signage, illumination, sound and light show, souvenir shop, etc. based on requirement and feasibility on case to case basis. Progress made in this regard is at Annexure.
- (b) Five (5) CPMs identified in Gujarat, as Adarash Smarak are (i) Rani-Ki-Vav, Patan, (ii) Champaner monument, Champaner, (iii) Archaeological Remains of a Harappan Port Town, Lothal, (iv) Dholavira and (v) Sun Temple, Modhera.
- (c) The improvement and upgradation of public facilities/amenities is a continuous phenomenon and is taken up depending on the availability of resources.
