4202. SHRI MAHESH SAHOO:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the progress of Pradhan Mantri Fasal Bima Yojana (PMFBY) in Odisha;
- (b) whether the Government will consider to hike the Centre and State share from 50:50 to 60:40 in PMFBY like the other central schemes; and
- (c) if not, the reason therefor?

ANSWER

(a) to (c) : State Government of Odisha is one of the major States implementing the Pradhan Mantri Fasal Bima Yojana (PMFBY) since its inception in 2016-17. Year-wise details of progress of the scheme from 2016-17 to 2021-22 is **annexed**. Government has recently revamped the Pradhan Mantri Fasal Bima Yojana (PMFBY) with effect from Kharif 2020 and interalia revised the premium subsidy sharing pattern for North Eastern States from 50 : 50 to 90 : 10 between Central and State Government. The premium sharing pattern of remaining States/UTs is 50 : 50 subject to certain conditions. At present, no proposal to revise the subsidy sharing pattern between Centre and State is under consideration of the Government.
