Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the details of services currently being provided to the Scheduled Castes, Senior Citizens and Persons with Disabilities (PwDs) by the Government in the country;
- (b) whether the Government monitors the work done by Non Governmental Organizations (NGOs) for Government schemes and if so, the details thereof; and
- (c) whether the Government has received any complaints against these NGOs during the last two years and if so, the details thereof including the action taken in this regard?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI A. NARAYANASWAMY)

(a) to (c): The focus of the Department's welfare effort is on the requirements of the poorest households as represented by the socially, educationally and economically marginalized sections of the society including Scheduled Castes (SCs), Other Backward Classes, Senior Citizens, Victims of Alcoholism and Substance Abuse, Transgender Persons, Beggars, Denotified and Nomadic Tribes (DNTs), Economically Backward Classes (EBCs) and Economically Weaker Section (EWS). The details of the Scheme being implemented by this Department for the welfare of Scheduled Castes, Senior Citizens and Persons with Disabilities (PwDs) are at Annexure-I.

The Ministry ensures monitoring of the Schemes to enhance transparency and accountability and checks the misuse of funds in the following manner -

- 1. Only online proposals by NGOs through e-Anudaan portal are considered for release of grants-in-aid.
- 2. The proposals of NGOs are considered on the basis of recommendations and satisfactory inspection reports of the State/UT Governments, and completeness of the proposals in all respects as per the guidelines of the scheme.
- 3. Subsequent grants are released to the implementing agencies, only on receipt of audited statement of accounts duly verified by Chartered Accountants and utilization certificates of the grants released in the previous year.

- 4. Performances of the NGOs are also monitored from time to time through random surprise inspections conducted by officers and PMU State Coordinators of the Ministry and representatives of State Governments. On the basis of the inspection report, necessary corrective action is taken.
- 5. The Ministry sponsors evaluation studies from time to time through independent evaluation agencies, inter-alia, to check proper utilization of funds by the implementing agencies under various Schemes/Programmes.
- 6. NGOs have to install CCTV and live feed has to be provided on its website.
- 7. NGOs registered on PFMS and implementing EAT Module for the purpose of proactive disclosure of their activities to the Public.

On the basis of the inspection report, necessary corrective action is taken. In respect of deficiencies reported, show cause notices are issued to the NGOs concerned and follow up action is taken on the basis of the replies received. In cases of misuse of funds, malfunctioning, non-functioning or deficient performance etc., the defaulting NGO is blacklisted and grant from the Government to the project is discontinued, after following the extant procedure.

Based on the report of inspection by PMU, this Department has stopped 170 projects in year 2020-21 & 43 projects in year 2021-22.
