FUNCTIONAL AIRPORTS

Will the Minister of CIVIL AVIATION

be pleased to state:-

(a) the details of the total number of airports in the country, Statewise;

(b) the number of airports which have been sanctioned during the last five years, State-wise;

(c) whether all these airports have become functional and if so, the details thereof and if not, the present status of construction;

(d) whether the Government proposes to construct sixteen more airports in the central region of the country and if so, the details thereof and the locations identified for the same;

(e) whether the newly proposed airports would be owned by the Government or private sector; and

(f) if so, the details of proposals received from various States including Kerala for the construction of new airports and the present status of each such proposal?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

(a): The details of Airports operated by Airports Authority of India and other agencies, State-wise, are attached as Annexure.;

(b) & (c): During the last five years, Government of India has accorded 'In-Principle' approval for development of new Greenfield airports at Hirasar (Rajkot) in Gujarat, Hollongi (Itanagar) in Arunachal Pradesh and Jewar (Noida) in Uttar Pradesh.;

The responsibility of implementation of airport project including funding of the project rests with the concerned airport developer and the respective State Government (in case the State Govt. is the project proponent). Out of the three airports approved during the last five years, Airports Authority of India is undertaking development of Hollongi and Hirasar airports and the works at both the airports have commenced. Jewar airport is a project of State Government of Uttar Pradesh which has undertaken the project under Public Private Partnership (PPP) mode. The State Government has handed over the project to M/s Yamuna International Airport Private Limited (YIAPL) and the works at the airport has been commenced. Timeline for completion of the airport projects depends upon many factors such as land acquisition, availability of mandatory clearances, financial closure, etc.;

(d) & (e): In the Central region, Gol has granted 'In-Principle' approval to M/s Gwalior Agriculture Company Limited (GACL), a private developer for setting up of Greenfield Airport at Dabra (Gwalior) in Madhya Pradesh. In addition, 'Site Clearance' approval has also been granted to the Madhya Pradesh Road Development Corporation Limited, a State Government agency, for setting up of a Greenfield Airport at Singrauli in Madhya Pradesh.;

Government of India, Ministry of Civil Aviation has launched Regional Connectivity Scheme (RCS) - UDAN (Ude Desh ka Aam Naagrik) in October, 2016 with the objective to facilitate / stimulate regional air connectivity to currently underserved and unserved airports. Under the Scheme, Gwalior Underserved airport in Madhya Pradesh owned by Indian Air Force (Civil Enclave-AAI) and Jagdalpur & Bilaspur airports in Chattisgarh owned by State Government have been operationalized. In addition, airports/airstrips at Ambikapur & Raigarh in Chattisgarh and Rewa in Madhya Pradesh have been identified for development and operationalization under RCS-UDAN.

(f): Proposals have been received from concerned State Governments for 'site clearance' for establishment of Greenfield Airports at Mandi in Himachal Pradesh, Pantnagar in Uttarakhand, Kottayam and Kasargod in Kerala, Purandar in Maharashtra and Raichur in Karnataka. As regards Mandi airport, Steering Committee has recommended site clearance subject to certain conditions which have to be fulfilled by the State Government of Himachal Pradesh. Matter of development of Greenfield Airport at Pantnagar is sub-judice. For Kottavam (Sabarimala) Airport, based on the observations of AAI and DGCA, Kerala State Industrial Development Corporation (KSIDC) has been requested to submit updated Techno Economic Feasibility Study **Report.** As regards, Kasargod airport, the State Government has clarified that the proposed airstrip is only for non-scheduled flights and not a full fledged Greenfield Airport. In respect of Purandar airport, **NOC** for Site Clearance has been cancelled by the Ministry of Defence (MoD). As regards site clearance for Raichur airport, the project proponent has been requested to provide additional information.
