Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- a) whether adequate medical facilitates are being made available in rural areas in the State of Chhattisgarh, if so, the details thereof;
- b) the extent to which National rural Health Mission has achieved its objectives in the country particularly in Chhattisgarh; and
- c) whether the Government proposes to establish super specialty healthcare centres in the rural areas and if so, the details thereof?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

a) to (c) Under National Health Mission (NHM), technical and financial support is provided to States/UTs for strengthening their healthcare systems, upto District Hospital level, based on the proposals submitted by them in their Program Implementation Plans (PIPs), subject to availability of resources. However, as per the information received from the State Government of Chhattisgarh, there are two Multi Super Specialty Hospitals which are approved in Bilaspur and Jagdalpur under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) scheme.

Adequate medical facilitates are available in rural areas in the State and the details thereof are as below as per information received from State Government of Chhattisgarh:
