MEDICAL TREATMENT UNDER AB-PMJAY

4986. SHRI SYED IMTIAZ JALEEL:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether the Government has signed Memorandum of Understanding (MoU) with private insurance companies for processing of claims under Ayushman Bharat Yojana;
- (b) if so, the details thereof;
- (c) whether the said MoUs is accessible in the public domain and if so, the details thereof;
- (d) if not, the time by which these are likely to be made available in public domain;
- (e) the number of beneficiaries treated for COVID-19 and non-COVID-19 diseases across the country under AB-PMJAY during FY 2019-20, 2020-21 and 2021-22, State/UT-wise; and
- (f) the amount of expenditure incurred for the treatment of COVID-19 patients under AB-PMJAY for FY 2019-20, 2020-21 and 2021-22, State/UT-wise?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (d): Under Ayushman Bharat -Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), States/UTs have the flexibility to implement the scheme in insurance mode or trust mode or mixed mode i.e. partly insurance mode and partly trust mode. Out of 33 States/UTs implementing the scheme, 10 States/UTs namely Dadra & Nagar Haveli and Daman & Diu, Gujarat, Jammu and Kashmir, Lakshadweep, Jharkhand, Maharashtra, Meghalaya, Nagaland, Rajasthan and Tamil Nadu are implementing it either in insurance mode or in mixed mode. States/UTs implementing the scheme in insurance/mixed mode directly enter into agreements with insurance companies. These agreements are accessible from the respective State Health Agencies.

(e) & (f): State/UT-wise details of authorized hospital admissions for COVID-19 and non-COVID-19 for FY 2019-20, FY 2020-21 and FY 2021-22 and the amount of claims for COVID-19 treatment under the scheme for FY 2020-21 and FY 2021-22 are at Annexure.
