# **†526. SHRI PRADEEP KUMAR SINGH:**

### Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

(a) the number of Jan Aushadhi Kendras opened across the country since the launch of Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP), State/UT-wise including Bihar;

(b) whether Jan Aushadhi Kendras have been established near every Government district hospital in the country and if so, the details thereof;

(c) the number of the districts where Jan Aushadhi Kendras have not been opened till now; and (d) whether these Kendras are proposed to be opened in such districts and if so, the timeline drawn in this regard?

### ANSWER

### MINISTER IN THE MINISTRY OF CHEMICALS & FERTILIZERS (DR. MANSUKH MANDAVIYA)

(a): Under the Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP), about 8,640 Pradhan Mantri Bhartiya Janaushadhi Kendras (PMBJKs) have been opened across the country till 31.12.2021, out of which about 276 PMBJKs have been opened in the State of Bihar. State/Union Territory- wise list of PMBJKs is enclosed as **Annexure**.

(b): Department of Pharmaceuticals has been requesting State/UT Governments to facilitate opening of Janaushadhi Kendras in the premises of Primary Healthcare Centers (PHCs)/Community Health Centers (CHCs)/Hospitals, including super specialty hospitals, by providing rent-free space within their premises. Further, Pharmaceuticals & Medical Devices Bureau of India (PMBI), the implementing agency of the scheme, also writes regularly to the State Governments/ District Magistrates in this regard. Due to these consistent efforts, about 1,060 PMBJKs have been opened in the Government premises as on 31.12.2021.

(c) & (d): Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP) has already marked its presence in all the districts of the country.
