- (a) the names of various schemes being implemented by the Ministry in Odisha at present;
- (b) the number of beneficiaries of such schemes, district-wise;
- (c) whether the funds under these schemes have been spent within the prescribed time limit, if so, the details thereof and if not, the reasons therefor;
- (d) whether the Government of Odisha has forwarded proposals requesting for release of funds under various schemes to the Ministry;
- (e) if so, the details of all those schemes where the release of funds to the Government of Odisha is pending along with the reasons therefor; and
- (f) the further steps taken/proposed to be taken by the Union Government for early release of funds in order to enable the Government of Odisha to carry out the said schemes successfully?

(b) & (c) The funds are released and utilized as per schematic norms. The number of beneficiaries is annexed at **Annexure-I**.

(d) to (f) The State Government of Odisha has forwarded proposals for release of funds under Swadhar Greh & Ujjawala Schemes.
