#### EXPENDITURE OF DoSJE & DEPWD

### 5339. SHRI MARGANI BHARAT:

## Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the reasons that the expenditure of the Department of Social Justice & Empowerment (DoSJE) and the Department of Empowerment of Persons with Disabilities (DEPwD) has come down from 11,088 crores in 2018-19 to 9098 crores in 2020-21;
- (b) Whether the Government has imposed cut due to above depleted expenditure;
- (c) the manner in which the Ministry would justify increase of Budget by just 0.3% in 2021-22 when compared to previous year considering inflation, etc.;
- (d) whether it does not come less than last year's Budget and if so, the manner in which the Ministry is managing with depleted funds and whether there is any reduction at the Revised Estimates (RE) stage and if so, the details thereof; and
- (e) the details of allocation made in 2022-23 to each scheme/programme?

### **ANSWER**

# MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI A. NARAYANASWAMY)

- (a): Yes Sir, the total expenditure of the Department of Social Justice & Empowerment and Department of Empowerment of Persons with Disabilities has come down from Rs. 11088.32 crore in 2018-19 to Rs. 9098.47 crore in 2020-21. The reasons for this decline in expenditure are as follows for both the Departments:
- 1.Department of Social Justice and Empowerment:

The Budget Allocation in the Scheme of Post Matric Scholarship for SCs during 2018-19 was Rs. 3000 crore. To release pending Central Assistance to State Governments as per Committed Liability in the Scheme, the allocation in the Scheme was revised to Rs. 6000 crore and the expenditure in the Scheme was Rs. 5928.16 crore. For this, the Department was provided with additional funds in Supplementary Demands for Grants. During 2020-21, the funding pattern under Post Matric Scholarship for SCs was changed to 60:40 and the expenditure was Rs.4010.16 crore. Since a major part of the Budget was allocated in the Scheme, the expenditure

of the Scheme affected the overall expenditure of the Department and the overall expenditure of the Department was low in 2020-21. Further, due to CoVID 19, the expenditure in Schemes was affected in 2020-21.

2.Department of Empowerment of Persons with Disability:

All the schemes in this Department are Central Sector Schemes, where funds are released to the implementing agencies based on demand/proposals whereby the Department itself has to ensure the monitoring and utilization of the funds released. In the last two years due to COVID 19 pandemic the organizations/institutions supported under the schemes are constrained in demand for funds as well as construction activities of the projects. However, it has been ensured that the voluntary organizations/NGOs still get financial support so that special schools, district rehabilitation centres do not face financial hardships.

- (b): No Sir, the Budgetary Allocation of the Ministry in 2020-21 was Rs. 11428.96 crore (Rs. 10103.57 cr. for DoSJE and Rs. 1325.39 cr. for DEPwDs) and the same in 2021-22 was Rs. 11689.39 crore (Rs. 10517.62 crore for DoSJE and Rs. 1171.77 crore for DEPwDs). The Budgetary Allocation of the Ministry in 2021-22 was thus increased by Rs. 260.43 crore.
- (c): The Budget of the Ministry was increased by 2.28 % and not 0.3% in 2021-22 as compared to previous year.
- (d): No Sir, it (2021-22 Budget) does not come less than last year's (2020-21) Budget.
- (e): The details of allocation made in 2022-23 to each scheme/ Programme is attached at **Annexure-I** (DoSJE) and **Annexure-II** (DEPwD).
