**PANCHAYATI RAJ SCHEME IN ODISHA**

5438. MS CHANDRANI MURMU:

Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) the details and names of various active schemes under the Panchayati Raj system in the State of Odisha and particularly in the districts of Keonjhar and Mayurbhanj; and
- (b) the details of funds allocated and spent under various schemes during the last five years, district and year-wise?

**ANSWER**

(a) The Ministry of Panchayati Raj (MoPR) is implementing (i) Centrally Sponsored Scheme (CSS) of Rashtriya Gram Swaraj Abhiyan (RGSA) with the primary aim of strengthening Panchayati Raj Institutes (PRIs), (ii) Incentivization of Panchayats (IoP), a Central Components of RGSA scheme under which, Awards including financial incentives are given to best performing Panchayats in recognition of their good work for improving delivery of services and public goods and (iii) Mission Mode Project on e-Panchayats, a Central component of RGSA scheme under which various e-governance projects are funded for promoting transparent, accountable and efficient rural local self-government. All these schemes are implemented for all States and Districts under them including the State of Odisha and the Districts of Kendujhar and Mayurbhanj.

(b) No fund is released under the Mission Mode Project on e-Panchayats. The year-wise Funds released/spent under the Schemes of Rashtriya Gram Swaraj Abhiyan (RGSA) and Incentivization of Panchayats (IoP) during the last five years is as follows:
