CRIME AGAINST CHILDREN

†5492. SHRI NIHAL CHAND:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether the cases about various crimes including crimes against children are being registered in the country and if so, the details thereof, State/UT-wise;**
- (b) the number of such cases registered, criminals arrested/convicted and cases solved during the last two years and the current year, State/UT-wise;**
- (c) whether the Government has prepared a list of States reporting major share of crimes including juvenile delinquencies and if so, the names of the States in which the incidence of crimes are increasing continuously;**
- (d) the remedial steps taken/being taken by the Government in this regard and the manner in which these States have been directed; and**
- (e) whether any awareness programmes are being run or proposed to be run to check criminal tendencies in the new generation and if so, the details thereof?**

ANSWER

(SHRI NITYANAND RAI)**

(a) to (e): National Crime Records Bureau (NCRB) compiles and publishes information on crime in its publication "Crime in India". The published reports are available till the year 2020. State/UT-wise details of cases registered about various crimes including crimes against children and juvenile delinquencies under Cognizable Indian Penal Code (IPC) and Special and Local Laws (SLL) Crimes during 2018-2020 are at Annexure-I. Further, State/UT-wise details of

cases registered, cases in which Trials Completed, persons arrested and persons convicted under Cognizable Indian Penal Code (IPC) and Special and Local Laws (SLL) Crimes during 2018-2020 are at Annexure-II.

'Police' and 'Public Order' are State subjects under the Seventh Schedule to the Constitution of India. The responsibilities to maintain law and order, protection of life and property of the citizens including investigation and prosecution of crime including crimes against children rest with the respective State Governments. The State Governments are competent to deal with such offences under the extant provisions of laws.

However, Government accords utmost priority to the safety of children. The Ministry of Home Affairs has issued various advisories from time to time on steps to be taken for effective prevention, detection, registration, investigation and prosecution of all crimes against Children, measures needed to prevent trafficking and to trace children, filing of FIR in case of missing children, kidnapping of minors, tackling of cyber crime relating to obscene content against children and safety and security of children living in Child Care Institutions.

The Juvenile Justice (Care and Protection of Children) Act (JJ Act), 2015 is the primary law for children in need of care and protection and children alleged and found to be in conflict with law. The JJ Act provides for setting up of a network

of services and structures for ensuring the well being and rehabilitation of such children which includes Juvenile Justice Boards, Special Juvenile Police Units, State and District Child Protection Units, Homes of various types and non-institutional care through adoption, foster-care and sponsorship.

Further, the Ministry of Women and Child Development is implementing “Child Protection Services” (CPS) (erstwhile Integrated Child Protection Scheme) with the objective to create a safe and secure environment for overall development of children in need of care and protection and children in conflict with law. The State Governments /UT Administrations are entrusted with the primary responsibility for implementation of the CPS Scheme.
