## SKILL DEVELOPMENT IN TEXTILE INDUSTRY

## 5632. SHRI SANJAY BHATIA:

Will the Minister of TEXTILES वस्त्र मंत्री be pleased to state :

(a) the details of the skill development programmes started for initiating the skill building of labourers in the textile industry sector;

(b) the number of textile training centres operating in Haryana including Karnal;

(c) the number of beneficiaries including those in Karnal District of Haryana under Integrated Skill Development Scheme (ISDS) and SAMARTH the during last three years and the current year;

(d) the amount allocated and utilized in Haryana for the above programme;

(e) whether the Government has ensured participation with Government agencies in cooperation with associations of various States for creation of employment opportunities both in traditional and organised sectors of training and textile value chain at entry level; and

(f) if so, the details thereof particularly in respect of Karnal District of Haryana?

## उत्तर ANSWER वस्त्र राज्य मंत्री (**श्रीमती दर्शना जरदोश**) THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

(a): With a view to address the critical gap of skilled manpower in textile industry through industryoriented training programmes, Ministry of Textiles introduced Integrated Skill Development Scheme (ISDS) as a pilot scheme in the last two years of  $11^{\text{th}}$  Five Year Plan (FYP). The scheme was scaled up as main phase during  $12^{\text{th}}$  FYP with an allocation of Rs.1,900 crore.

In further continuation, Ministry of Textiles has expanded the skill development programme, namely, Samarth- Scheme for Capacity Building in Textile Sector, in alignment with overall skilling framework prescribed by Ministry of Skill Development and Entrepreneurship. The Scheme initially approved for implementation from 2017-18 to 2019-20 has been extended upto 31.03.2024. The scheme provides industry oriented entry level and upskilling programmes.

(b): A total of 28 training centres under Samarth scheme are operating across Haryana including Karnal District.

(c): The details of beneficiaries including those in Karnal District of Haryana under Samarth during last three years and current year is as follows:

(d): There is no state-wise allocation of funds under Samarth. The cost of training programme is released directly to Implementing Partners. The Implementing Partners in Haryana have trained a total of 4,650 beneficiaries with a cost coverage of about Rs. 6.51 crore.

(e) & (f): In order to ensure participation of State Governments in implementation of placement oriented skilling programme in organized sector and skilling/ upskilling programmes in traditional sector under Samarth, Ministry of Textiles has entered into MoU with 18 State Government Agencies. A total of 14 agencies which completed submission of detailed training proposals have been allocated a target to train 92,424 beneficiaries under the Scheme. However, the State agency in Haryana viz Haryana Skill Development Mission has not submitted the detailed training proposal.
