ASPIRATIONAL DISTRICTS IN BIHAR

†5634. SHRI DILESHWAR KAMAIT:

Will the Minister of PLANNING be pleased to state:

- (a) whether Supaul district is among the developed districts of Bihar;
- (b) if so, the position of Supaul district in terms of data set and weightage points wise in comparison to other districts for their selection under Aspirational District Programme;
- (c) the details of the data set and weightage point of various districts of Bihar including Supaul;
- (d) the dates on which the selection process has been carried out to select comparatively lesser developed districts for their fast development under Aspirational Districts Programme, year-wise;
- (e) whether Supaul has also been considered under the said selection process; and
- (f) whether the Supaul is a flood prone area thereby halting its development process due to occurrence of floods every year; and
- (g) if so, the basis on which Supaul district has not been included on the said programme?

ANSWER

- (a) Currently, there is no provision in Niti Aayog for declaring any district as developed or otherwise.
- (b) In January 2018, NITI Aayog identified districts through a transparent process which had shown relatively lesser progress in key socio economic indicators. These districts were termed as the Aspirational Districts and a programme was launched to rapidly transform these districts. As per this method, eight districts selected in Bihar as Aspirational Districts had overall lesser progress than Supaul district in 2018. In addition, 5 more districts identified by the Ministry of Home Affairs in Bihar as districts adversely affected by the Left Wing Extremists were also termed as Aspirational Districts. Supaul did not figure in this list. List of 13 Aspirational districts in Bihar is placed at **Annexure-II**.

- (c) to (d) List of data sets and the weight attached to them for selection of these districts is provided at **Annexure I**. They are available in the public domain. Based on the data values as available in 2018, and weights attached, an index value of all districts in the country was computed using a standardised statistical method to normalise the data. Subsequently, based on their index values, the districts were ranked. In addition to this, 35 Districts, categorized as "most-affected" by Left Wing Extremism by Ministry of Home Affairs were also included. Further, effort was made to include at least one low-scoring District from each State. NITI Aayog shared the list of shortlisted districts with the State Governments concerned with a request that in case the State suggested any change, it would be considered. No request for any change was received from the Government of Bihar. The selection process was finalised by January 2018.
- (e) Yes sir. Since the data pertaining to all the districts in Bihar were examined for shortlisting the district, Supaul District was considered while carrying out the exercise to rank districts as mentioned in (c) to (d) above.
- (f) The district wise list of flood prone areas is not centrally maintained. However, the assessment of flood prone areas of the country has been carried out by different expert committees, and the extent of maximum area affected by floods in any year during 1953-2010 has been estimated as 49.815 mha, the State-wise break up of which is given at **Annexure III**.
- (g) Districts shortlisted in Bihar either had shown a lesser progress in selected socio-economic indicators than Supaul by 2018 or were more affected by left Wing Extremism. Hence Supaul was not selected.
