(a) The Central Council for Research in Ayurvedic Sciences (CCRAS), an autonomous body under Ministry of AYUSH, Government of India, is an apex body in India for undertaking, coordinating, formulating, developing and promoting research on scientific lines in Ayurvedic Sciences. The activities are carried out through its 30 Institutes/Centres/Units located all over India and also through collaborative studies with various Universities, Hospitals and Institutes. The research activities of the Council include Medicinal Plant Research, Drug Standardization, Pharmacological Research, Clinical Research, Literary Research & Documentation and Tribal Health Care Research Programme. The details of financial assistance provided to CCRAS during the last two years from 2019-20 onwards are as under: -
