(a) & (b): Additional foodgrains @ 5 kg per person per month for around 264 lakh beneficiaries including those in Ranchi Parliamentary Constituency under Phase-I-Phase V of Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) have been allocated to State of Jharkhand for free of cost distribution.

Targeted Public Distribution System (TPDS) is operated under the joint responsibility of the Central and the State/UT Governments. The responsibility of identification of beneficiaries under National Food Security Act (NFSA) (and PMGKAY also, as targeted beneficiaries are same) and further sub allocation and distribution of foodgrains to districts within the State/UT lies with respective State/UT. Information regarding district-wise details of foodgrains distributed to Jharkhand and beneficiaries benefitted under PMGKAY as received from State Govt, is at Annexure-I & II respectively.

(c): Govt. of India is bearing the entire expenditure towards this Scheme without any contribution by States/UTs
