Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

(a) the Skill Development Centres set up in the country State/UT wise including Rajasthan, Jharkhand, Jhansi and Lalitpur in Uttar Pradesh, Assam, Bihar, Haryana, West Bengal and Tamil Nadu;

(b) the ranking of the States including Rajasthan with regard to Skill Development and Entrepreneurship in the country;

(c) the number of persons who have been received training from these Skill Development Centres since their inception to till date;

(d) whether the persons who received training from Skill Development Centres have got suitable employment in the market; if so, the details thereof State/UT wise; and it not, the reasons therefor;

(e) the action plan proposed by the Government to overcome the present lacunae in the training module of these Skill Development Centres;

(f) the details of the funds allocated/ utilized for Skill Development Cetres/ Training Sate/UTwise including Tamil Nadu;

(g) whether the Government propses to promote women participation in skill training programmes; and if so, the detials thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJEEV CHANDRASEKHAR)

(a) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship (MSDE) is implementing various programmes/ scheme for the skill development of youth across the country such as Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS) and Craftsmen Training Scheme (CTS) through Industrial Training Institute (ITIs). The State-wise number of skill development training centres (TCs), including TCs in Lalitpur and Jhansi districts of Uttar Pradesh, are given at *Annexure I*.

(b) Under PMKVY, JSS and CTS as on 31.12.2021, around 2.21 crore candidates have been trained/enrolled. Details are given below:

(c) Above reply (b) may be referred to.

(d) Yes, Sir. Under PMKVY, placement opportunities are being provided to Short Term Training (STT) certified candidates, while Recognition of Prior Learning (RPL) does not mandate placements as it recognizes the existing skills of candidate. Under PMKVY-STT (since inception, i.e., 2015 till 31.12.2021), 53.89 lakh candidates have been certified; out of which, 23.70 lakh candidates have been provided with the placement in various sectors across the country. The state-wise details are given at *Annexure III*.

(e) Based on the evaluation studies and learning from the implementation of PMKVY 1.0 and 2.0, Ministry has launched the new and modified version of PMKVY, i.e., PMKVY 3.0 (2020-21) on 15.01.2021. Under the PMKVY 3.0, the informed choices / aspirations of the candidates have been given primacy and it promotes candidates to opt for local skills with local jobs. Demand-driven with bottom-up approach has been adopted under PMKVY 3.0.

District Skill Committee (DSCs) is the focal point for implementation of PMKVY 3.0 at the district level. The DSCs are entrusted with district level skill gap and demand assessment, mobilization and counselling of candidates, formation of training batches, post training support and provide handholding support to the candidates after placements, besides addressing the grievances, if any. Further, to improve the monitoring, District Skill Committee (DSC) is being involved and entrusted with the monitoring under PMKVY 3.0. DSC acts as an on-ground monitoring agency for conducting inspection of TCs.

(f) The PMKVY (except PMKVY 1.0 (2015-16) has two components, namely, Central component being implemented through National Skill Development Corporation (NSDC), and State component being implemented through State Skill Development Mission of the State/UT. Under Central component of PMKVY, there is no provision of State-wise funds allocation. Since inception of the PMKVY, i.e., 2015, as on 31.12.2021, an amount of Rs. 8,590.29 crore has been disbursed to implementing agency, i.e., NSDC towards the implementation of the scheme.

Under the State component of PMKVY, funds and corresponding physical targets have been allocated to the States for the implementation of scheme through State Skill Development Missions (SSDMs). Since incorporation of State component, i.e., 2016, as on 31.12.2021, an amount of Rs. 1,224.82 crore has been disbursed to States for the implementation of the scheme. The State-wise funds allocated, disbursed and utilized by the State under PMKVY 2.0 and PMKVY 3.0, as on 31.12.2021, is given at *Annexure IV*.

There is no provision of state-wise allocation of funds for imparting training under JSS and ITI.

(g) Yes, Sir. All schemes of the Ministry of Skill Development and Entrepreneurship are for the skill development of youth including women. The Ministry has undertaken several initiatives to achieve women empowerment through skill development. The National Policy on Skill Development and Entrepreneurship focuses on inclusive skill development, with the objective of increased women participation for better economic productivity. Under PMKVY, in order to increase the participation of women, conveyance cost and boarding & lodging facilities are being provided. Further, the priority group under JSS includes women. Under long term skilling, ITIs exclusively of women have been set up across the country. In addition, 30% of the seats in general ITIs are reserved for women trainees subject to the general reservation policy of the respective State.
