- (a) whether the Union Government has provided assistance to Odisha during the period of Covid-19 pandemic; and
- (b) if so, the details of assistance provided to Odisha during the said period, year-wise and project-wise?

(a) to (b): The Union Government had announced Emergency Response and Health System Preparedness Package, Pradhan Mantri Garib Kalyan Yojana (PMGKY), Aatma Nirbhar Bharat (ANB) Packages, Special Assistance to States for Capital Expenditure and back to back loan to meet shortfall in GST Compensation in order to provide assistance to States during the COVID-19 period. The ANB Packages, which comprises of various long-term schemes/programmes/policies are aimed at making the country self reliant. Further, the additional borrowing limit of upto 2 percent of GSDP over and above normal borrowing limit of 3 percent of GSDP for the year 2020-21 and advance releases towards State Disaster Response Fund (SDRF) has been allowed to the State of Odisha. The item-wise assistance provided by the Union Government to the State of Odisha during the COVID-19 pandemic is provided in Annexure.
