TRAINING CENTRES WITH IT ENABLED

742. COL. RAJYAVARDHAN RATHORE:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the details of total funds allocated since the inception of the scheme, State/Year-wise;
- (b) the details of number of training centres with Information Technology enabled infrastructure, Statewise and down to district level for Rajasthan;
- (c) whether the Government plans to extend the scheme timelines due to the severe impact of Covid-19 pandemic on the livelihood and learning capabilities of Indian youth;
- (d) the details of number of male and female candidates enrolled, state wise and year wise, whether the Government is taking further efforts to ensure female candidates in remote areas;
- (e) the steps taken by the Government to trickle down the benefits of the scheme to grassroot rural and tribal areas; and
- (f) details of total number of Kaushal and Rozgar Melas held, State/Year-wise and down to the district level for Rajasthan since the inception of the scheme?

ANSWER

**MINISTER OF STATE IN THE MINISTRY OF
SKILL DEVELOPMENT AND ENTREPRENEURSHIP
(SHRI RAJEEV CHANDRASEKHAR)**

(a) Under Skill India Mission, the Ministry of Skill Development (MSDE) has been delivering skills through Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS) Scheme, National Apprenticeship Promotion Scheme (NAPS) and Industrial Training Institutes (ITIs).

The PMKVY (except PMKVY 1.0 (2015-16) has two components, namely, Central component being implemented through National Skill Development Corporation (NSDC), and State component being implemented through State Skill Development Mission of the State/UT. Under Central component of PMKVY, there is no provision for State-wise funds allocation. Since inception of the PMKVY, i.e., 2015, as on 31.12.2021, an amount of Rs. 8,590.29 crore has been disbursed to implementing agency, i.e., NSDC towards the implementation of the scheme.

Under State component of PMKVY, funds and corresponding physical targets have been allocated to the States for the implementation of scheme through State Skill Development Missions (SSDMs). Since incorporation of State component, i.e., 2016, as on 31.12.2021, an amount of Rs. 1,224.82 crore has been disbursed to States for the implementation of the scheme. The State-wise funds allocated, disbursed and utilized by the State under PMKVY 2.0 and PMKVY 3.0, as on 31.12.2021 are placed in **Annexure I**. For the other scheme, the figures are placed at **Annexure II** for JSS, **Annexure-III** for NAPS and **Annexure-IV** for upgradation of existing ITIs into model ITIs. All figures are given since inception till 2020-21, except in the case of PMKVY State Component for which data have been provided till 31.12.2021. The JSS and NAPS were transferred to the Ministry in 2018.

(b) The details of number of training centres at district level in Rajasthan under PMKK, JSS & CTS is attached at **Annexure V**. All the centres have access to Information Technology. Further, All courses under PMKVY give over thirty hours of training on digital literacy to equip them coping up with changing times.

(c) All the Schemes of the Ministry are ongoing ones. However, the Ministry has taken various initiatives to mitigate the impact of COVID-19 pandemic on skill development training:

- (i) Special programme for training of reverse migrants under PMKVY;
- (ii) COVID Allowance to training centres;
- (iii) Customized Crash Course Programme for COVID Warriors; and
- (iv) Introduction of On-line skill training.

(d) The details of number of male and female candidates enrolled under PMKVY, JSS, NAPS and JSS, state-wise and year-wise is placed at **Annexure VI**, **Annexure VII**, **Annexure VIII** & **Annexure IX** respectively. All figures are till 2020-21, except for the ITIs for which figures are calendar year-wise, till 2020.

(e) The Ministry of Skill Development & Entrepreneurship through the Directorate General of Training, an attached office, is implementing schemes titled “Enhancing Skill Development Infrastructure in NE States” and “Skill Development in 47 Districts Affected by Left Wing Extremism”, for funding State Governments for establishment of Industrial Training Institutes (ITIs) in the country.

(i) Efforts for Tribal Areas: As far as the tribal areas or ST communities are concerned, the following additional benefits are given to tribal candidates under the different skill development of schemes:

SI No	Scheme	Benefit for tribal candidates
1	JSS	Course fees are waived for the SC, ST, Divyangjan & BPL category beneficiaries
2	ITIs	Benefits are extended as per State/UT policy

(ii) Efforts for Aspirational Districts: MSDE through its Transformation of Aspirational Districts programme aims to identify challenges for skill development in districts and co-

creating customized solutions for overcoming these challenges. The programme hinges on expeditiously transforming 117 districts that were identified across 28 States.

(iii) Other Measures for the NER within Pan- India Schemes: As per the Common Norms for Skill Development Schemes, Additional Support for Special Areas/ Training in Special Areas, over and above the Base Cost, an additional amount equal to 10% of the Base Cost should be permitted for Skill Development programmes conducted in the North Eastern States, Jammu & Kashmir, Himachal Pradesh, Uttarakhand, Andaman & Nicobar Islands, Lakshadweep and districts affected by Left Wing Extremism (LWE) as identified by the M/O Home Affairs for the Integrated Action Plan. Under the JSS, course fees are waived for the SC, ST, Divyangjan & BPL category beneficiaries and under ITIs benefits are extended as per relevant policy of the State/UT Government/Administration.

(iv) Jan Shikshan Sansthan (JSS) aims to provide vocational training to non-literates, neo-literates as well as school drop-outs in rural regions by identifying skills that have a relevant market in that region. Over two-thirds of India's population comprises rural citizens. The objective of JSS is to uplift this rural population economically by imparting essential skills training, thereby enabling local trades to grow and creating new opportunities for the natives of the region.

(f) Details of total number of Kaushal and RozgarMelas held, State/Year-wise and down to the district level for Rajasthan the inception of the scheme may be seen at **Annexure X**
