TRAINING TO TRIBAL WOMEN

813. SHRI RAJAN VICHARE:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the scheme-wise details of the proposals received and approved under various loan schemes for the development of tribal women of Maharashtra during the last three years and the current year;
- (b) the number of beneficiaries under the said loan scheme, year-wise;
- (c) the details of the amount of loan granted by Government for setting up industries after providing training to the tribal women; and
- (d) if so, the details thereof and if not, the reasons therefor?

(a) Ministry of Tribal Affairs extends concessional loans to the eligible Scheduled Tribe persons through National Scheduled Tribes Finance and Development Corporation (NSTFDC), for undertaking income generation activities / self-employment. Under the loan scheme of NSTFDC, the details of proposals received from the State of Maharashtra for women beneficiaries during the last three years and current year upto (31.01.2022) is given below:
