The timeline for completion of PMGSY-I & II is September 2022. It is March, 2023 for RCPLWEA and March, 2025 for PMGSY-III.

Reasons for delay in completion of these projects are delay in award of projects by the state, delay in forest clearance, lack of response by contractors and difficult working conditions for a number of projects, especially those falling in areas affected by left-wing extremism.
