## STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (d) OF LOK SABHA STARRED QUESTION NO. \*149 DUE FOR ANSWERED ON 27.07.2022 RAISED BY SHRI P.P. CHAUDHARY & SHRI DUSHYANT SINGH REGARDING SETTING UP OF INCUBATION CENTER.

(a): Under the Pilot Scheme for setting up Incubation Centers in Apparel Manufacturing, three projects were sanctioned by the Government. The Scheme envisaged infrastructure support and capacity building support. As part of capacity building, training was given to 200 workers per incubatee for 3 months with an aim to provide placement oriented skilling to an individual thereby supporting the efforts of the industry in creating jobs in the organized textile sector. The criteria for the selection of 200 workers for training support was in accordance with the norms of SAMARTH, a scheme for capacity building in textile sector. The trainee must be a citizen of India possessing an Aadhaar Card with age over 14 years.

The present reformed SAMARTH, addresses the requirements of the industry and other stakeholders in a transparent manner by giving opportunity to all willing persons. Preference is given to the marginalized social groups like women, SC/ST, differently-abled persons, minorities, persons from the BPL category and 115 Aspirational Districts notified by the NITI Aayog. In addition, a web and Mobile App based platform is operational, wherein the interested candidates can indicate willingness for training.
