#### **UPGRADATION OF STATE HIGHWAYS**

#### \*169. SHRI PRAJWAL REVANNA:

#### Will the Minister of ROAD TRANSPORT AND HIGHWAYS

सडक परिवहन और राजमार्ग मंत्री

#### be pleased to state:

- (a) whether the Government proposes to grant in-principle approval to upgrade State Highway (SH) connecting Channarayapatna in Hassan district with Makutta on Karnataka-Kerala border into National Highway (NH);
- (b) if so, the details thereof and the time by which it is likely to be approved and the funds allocated/ sanctioned for the purpose;
- (c) the present status of work on Hassan-Sakleshpura stretch of NH-75 which is pending for many years along with the reasons for such a long pendency;
- (d) the funds allocated, released and utilised on the said stretch;
- (e) whether the Government has blacklisted the concerned contractor for non-completion of work on the said stretch and if so, the details thereof; and
- (f) the steps taken by the Government to complete the said project within the stipulated time period?

#### **ANSWER**

(a) to (f) A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (f) OF LOK SABHA STARRED QUESTION NO. 169 FOR ANSWER ON 28/07/2022 ASKED BY SHRIPRAJWAL REVANNA REGARDING UPGRADATION OF STATE HIGHWAYS.

(a)&(b) The State Highway connecting Channarayapatna in Hassan district with Makutta on Karnataka-Kerala border is a State Government Road. Ministry keeps on receiving proposals for declaration of State Roads as National Highways from different States and Union Territories including from the State of Karnataka. Ministry considers some of these proposals for declaration as National Highways depending on the requirements of connectivity, traffic levels, inter-se priority and availability of resources. During the last three years and the current year, 2 Green Field Alignments with lengths of 77 km and 177 km respectively falling in the State of Karnataka have been declared as NE-7 and NH-150C respectively.

(c) 4 laning of Hassan to Sakleshpur stretch of NH-75 in a length of 35 km has been taken up by NHAI as part of Hassan to Maranhally section of NH-75. Out of this, 24.39 km has already been completed. Physical progress of the Hassan–Maranhally 4 laning work is 48% and the project is likely to be completed by 17-03-2023. Due to insolvency of the original contractor, a new contractor was appointed and the work is in progress. Apart from this, delay in quarry / mining permissions, COVID pandemic, short working season due to prolonged rains in ghat sections also contributed to the delay in this work.

## (d) The funds allocated / released and utilized on the said stretch are as below

- (e) The main contractor, M/s. Isolux Corsan Engg. Pvt. Ltd. has been declared insolvent. Hence, the question of blacklisting the contractor does not arise.
- (f) Required permissions have been obtained with appropriate interventions and the work is being monitored regularly at various levels including reviews by Chief Secretary to Government of Karnataka, Chairperson (NHAI) and Secretary (RTH) from time to time to complete the work within the extended time.
