**STATEMENT REFERRED TO IN REPLY TO LOK SABHA
STARRED QUESTION NO. 184* FOR 29TH JULY, 2022**

(a) to (c): Government of India is making all efforts to strengthen Sub-Centres and Primary Health Centres as part of comprehensive primary health care by implementing a flagship programme Ayushman Bharat-Health and Wellness Centres (AB-HWCs). This is India's commitment for achieving promotive, preventive, curative, palliative and rehabilitative aspects of Universal Health Coverage with a goal to provide Comprehensive Primary Health Care including both maternal and child health services and non-communicable diseases as well as free essential drugs and diagnostic services through Health and Wellness Centres.

Under Ayushman Bharat, States/UTs are supported to transform existing 1.5 lakh Sub Health Centres (SHCs) and rural and urban Primary Health Centres (PHCs) across the country as Ayushman Bharat - Health and Wellness Centres (AB-HWCs) by December, 2022 with an aim to provide Comprehensive Primary Health Care (CPHC) that includes prevention and health promotion at the community level with continuum of care. A total of 1,20,112 Ayushman Bharat- Health & Wellness Centre (AB-HWCs) are functional in the country as on 30th June 2022. State-wise details is at **Annexure-I**.

Ministry of Health and Family Welfare provides technical and financial support to the States/UTs to strengthen the public healthcare system, based on the proposals received from them in their Annual Programme Implementation Plans (PIPs), within their resource envelope.

The States/UTs are supported for various components under AB-HWCs namely engagement of Community Health Officer (CHO) and capacity building of primary health care team, performance based incentives for the team at AB-HWC, infrastructure strengthening, availability of medicines and diagnostics, provision of expanded range of services including wellness through yoga, telemedicine etc.

There is equal focus on preventive healthcare and health promotion activities at AB-HWCs. Ayushman Bharat - Health and Wellness Ambassador Initiative has been launched where in teachers in every school are Ambassadors to foster growth, development and educational achievement of school going children by promoting their health and wellbeing. In AB-HWCs, there have been 101.03 crore footfall upto 30th June, 2022. Screening of 21.41 crores individuals for hypertension and 17.83 crore for diabetes has been done at HWCs till 30th June, 2022. Screening for three common cancers which include oral (11.81 crore screened), breast (5.73 crore women screened) and cervical cancer (3.86 crore women screened) done across the country at HWCs till 30th June, 2022. More than 1.21 crores Yoga / other Wellness sessions have been conducted at HWCs till 30th June, 2022. Further, at HWCs convergence with Eat Right Movement of Food Safety and Standards Authority of India (FSSAI) is built on two broad pillars: "Eat Healthy" and "Eat Safe".
