- (c) the details of the number of proposals submitted by the State Government still pending for approval under the Ministry of Fisheries, Animal Husbandry and Dairying since 2017, yearwise?

# STATEMENT REFERRED IN REPLY OF LOKSABHA STARRED QUESTION NO. 223 PART (a) to (c) ON NATIONAL LIVESTOCK MISSION

(a) The total funds released and utilized by the State of Telangana under National Livestock Mission since 2014-15 to till date are as under. The State-wise and year-wise similar information for country is further annexed.

- (b) Provision of mobile veterinary clinics was introduced in revised Livestock Health and Disease Control (LH & DC) Schemes from 2021-2022 only. Prior to that there was no provision of mobile veterinary clinics in any Central Government Scheme including ASCAD Scheme. After commencement of revised LH & DC Scheme, action has been taken to sanction mobile veterinary units to states on demand. In 2021-22, under LH&DC scheme Rs. 1600 lakh has been provided to the State of Telangana for procurement & running of 100 Mobile Veterinary Unit (MVUs) during 2021-22.
- During 2021-22, the Animal Husbandry Department, Telangana State submitted proposals under NLM seeking financial assistance of Rs. 6956 lakh on 20<sup>th</sup> September, 2021 and 5<sup>th</sup> November, 2021 for implementation of various components of NLM and Rs.542.76 lakh has been sanctioned. The remaining is kept pending as the State had unspent balance of Rs. 2079.91 lakh out of the funds released during 2019-20 and 2020-21 under the proposed components at the time of submission of the proposals and further, as per the financial norms releases in respect of the proposals submitted in 2021-22 can only be made once the State submits the utilisation certificate for the funds released earlier. The same has been communicated to the State in a letter dated 27<sup>th</sup> January, 2022.

In addition, a research proposal named 'Development of point of care diagnostic assays for major infectious pathogens of sheep and goat - A disease management approach to enhance small ruminants productivity' seeking funding of Rs.144.2 Lakhs was received from P.V. Narsimha Rao Telangana Veterinary University on 6<sup>th</sup> April, 2022 which has been examined and additional information was sought on 12<sup>th</sup> May, 2022. Reply is still awaited. State of Telangana has not submitted any proposal under NLM for the year 2022-23.

Annual Action Plan proposal for 2022-23 has been received from the State of Telangana on 30.06.2022 seeking assistance for Rs. 16289.49 lakh for implementing programme related to 'Assistance to State for Control of Animal Disease' (ASCAD), Foot & Mouth Disease (FMD), Brucellosis and Peste des Petits Ruminants under Livestock Health and Disease Control Programme. Similarly, the Action Plan for an amount of Rs. 103.80 lakh for implementing the Integrated Sample Survey for Estimation of major livestock products (ISSS) for the year 2022-23 has been received on 21.06.2022 The proposals have been examined and the State has been asked to submit the required documents vide email dated 22.06.2022.
