(a) whether the Government has launched the new draft National Youth Policy (NYP) 2021 which envisages a ten-year vision for youth development that India seeks to achieve by 2030;

(b) if so, the details thereof including the objectives, summary of recommendations etc.;

(c) whether the draft NYP seeks to catalyse widespread action on youth development across five priority areas and if so, the details thereof;

(d) whether the Government has formulated any implementing strategy or monitoring and evaluation mechanism to track the progress of NYP, if so, the details thereof; and

(e) the other steps taken/being taken by the Government for the development of youth in the country?
