- (a) the industrial nodes identified under various Industrial Corridors in Karnataka and Maharashtra;
- (b) the status of development of each industrial node like detailed master planning, preliminary engineering, etc.;
- (c) the present status of area with regard to identification of land, formation of Special Purpose Vehicle (SPV), transfer of land to SPV, infrastructure development, etc.;
- (d) the cost estimates for various infrastructure components along with the contribution from Central Government for different nodes; and
- (e) the status of funds released for each area and the employment potential of each node?

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF THE LOK SABHA STARRED QUESTION NO. 245 FOR ANSWER ON 03<sup>TH</sup> AUGUST, 2022.**

**(a) to (e):** Government of India has accorded approval for development of 11 corridors (32 projects) in four Phases. The status of development of industrial nodes identified under Industrial Corridors programme in the States of Maharashtra and Karnataka are as under :-

**MAHARASHTRA**

**(1) Delhi - Mumbai Industrial Corridor (DMIC):**

**(i) Shendra Bidkin Industrial Area (SBIA):-** Special Purpose Vehicle (SPV) has been incorporated. State Government has transferred entire 8.39 sq kms land for Shendra Industrial Area and 28.8 sq. kms for Bidkin Industrial Area to the SPV. Matching equity amounting to Rs. 602.80 crore and 2397.20 crore respectively has also been released by Government of India (GoI) to the SPV.

For Shendra Industrial Area, tender packages for various infrastructure components for Rs. 1533 crore have been approved and major trunk infrastructure works have been completed. 172 plots (375 acre) have already been allotted to industries and the estimated investment is Rs. 5,542 crore. Hon'ble Prime Minister has dedicated the project to the Nation on 7<sup>th</sup> September, 2019.

For Bidkin Industrial Area, infrastructure packages worth Rs. 6414.21 crore have been approved. The trunk infrastructure works for Sector A (10.32 sq. km) have already been completed. For the entire SBIA, 2,160-acre industrial land has been developed. Estimated employment generation, as per the Development Plan (for 84 sq. kms), for SBIA is 7.5 lakhs (Direct/indirect).

**(ii) Dighi Port Industrial Area (DPIA)** – Master planning has been completed. Preliminary Design Report (PDR) along with costing for implementation of Phase-I (2,712 acres) has been undertaken.

**(2) Bengaluru - Mumbai Industrial Corridor (BMIC):**

**Satara Industrial Area** – For Master Planning, consultants have been appointed.

**KARNATAKA**

**(1) Chennai Bengaluru Industrial Corridor (CBIC):**

**Tumakuru node** - Detailed master planning and preliminary engineering activities (1,736 acre Activation Area) has been completed. State Govt. has transferred 1668.30 acre of land to the SPV of the project and matching equity amounting to Rs. 586.74 crore has been released by GoI. Environment Clearance has been obtained. Estimated employment generation is 3,66,000 persons(direct/indirect).

**(2) Bengaluru Mumbai Industrial Corridor (BMIC):**

**Dharwad Industrial Area** - Govt. of Karnataka has confirmed availability of 6,400 acre of land for development of industrial node at Dharwad. Project development activities such as Detailed Master Planning and Preliminary Engineering activities have already been undertaken.
