EXPENDITURE ON MEDICINES AND PRESCRIPTION DRUGS

*283. SHRI RAJIV PRATAP RUDY:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the details of consumption of medicines and prescription drugs in the country, State-wise;
- (b) whether Bihar is amongst the highest consumer of medicines and prescription drugs in the country, if so, the details thereof;
- (c) the per capita expenditure on medicines and prescription drugs purchased in the country, State/UT-wise including Bihar;
- (d) whether the Government has data on per household or per capita out of pocket expenditure on purchase of medicines; and
- (e) if so, the details thereof, State/UT-wise?

(a) to (e): 'Public Health' being a State subject, the information related to consumption of medicines and prescription drugs in the States is not maintained centrally.

The National Health Accounts (NHA) Estimates for India 2017-18 database provides information on both, prescribed medicines as well as over-the-counter medicines (OTC) consumed by the households. Per capita Out of Pocket Expenditure (OOPE) on prescribed medicine for outpatient care in Bihar in 2017-18 was Rs. 198/while for OTC medicines, per capita OOPE was Rs 100/-. In comparison with the other states, Bihar ranks lowest in prescribed medicines and for OTC medicines, it is ranked sixth in the list of 21 states ordered from lowest to highest as per their per capita expenditure on OTC medicines. In case of overall medicine, Bihar's rank is lowest. This indicates low consumption of medicine in the state of Bihar.
