STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF LOK SABHA STARRED QUESTION NO. *303 TO BE ANSWERED ON 08.08.2022 ASKED BY SHRI Y.S. AVINASH REDDY REGARDING 'PM-YUVA'

(a) & (b) The Ministry of Skill Development and Entrepreneurship in association with Wadhvani Operating Foundation (WOF) launched the Pradhan Mantri Yuva Udyamita Vikas Abhiyan (PM-YUVA) Yojana on 9th November, 2016 with the objective to create an enabling ecosystem for entrepreneurship development through entrepreneurship education and training across the country. This was implemented in Institutes of Higher Learning (Colleges, Universities, Polytechnics). A total of 239 Institutes of Higher Learning were empaneled across 26 States/ UTs. However, the scheme was restructured in June 2018 to include skill training institutes under MSDE, viz. Industrial Training Institutes (ITIs), Jan Shikshan Sansthan (JSS), Pradhan Mantri Kaushal Kendra (PMKK), Polytechnics. The number of beneficiaries reached through PM-YUVA 1.0 (state-wise) is given in **Annexure-I**.

Based on the learnings from PM YUVA Phase-I, NIESBUD rolled out Phase-II of the PM-YUVA on its own from 2019. Ministry of Skill Development and Entrepreneurship (MSDE) implemented project on Entrepreneurship Development (PM YUVA Phase-II) through NIESBUD, at an estimated cost of Rs.12 Cr upto March, 2022, in around 300 institutes under the skill ecosystem. The aim of the Pilot Project was to promote entrepreneurship as an alternate career choice and provide mentoring support to potential and early-stage entrepreneurs by imparting entrepreneurship education and mentoring support to trainees/ beneficiaries from skill ecosystem. The project was implemented through organizations having experience in entrepreneurship development, entrepreneurship training as well as mentoring and handholding in 10 States and 2 Union Territories (viz. Uttar Pradesh, Uttarakhand, Bihar, West Bengal, Assam, Meghalaya, Maharashtra, Tamil Nadu, Telangana, Kerala, Delhi and Puducherry). The scheme envisaged creation of 600 new and 1000 scaleup enterprises, against which 1045 new enterprises were set-up and 968 existing enterprises were scaled-up. Further, the details of activities undertaken under the Pilot Project is given in **Annexure-II**.

In consultation with National Council for Vocational Education and Training (NCVET), Ministry of Skill Development and Entrepreneurship (MSDE) has now embedded Employability skills programme (which includes Entrepreneurship education) in all its long term and short term programmes, with approximately 10% of course duration. Approximately 25 lakh students of ITIs and all other students of short term courses benefit from this programme. Under National Education Policy (NEP) 2020, Employability Skills/Entrepreneurial skill courses are being introduced by National Council of Educational Research and Training (NCERT) in Schools and by All India Council for Technical Education (AICTE) and University Grants Commission (UGC) in higher education courses.
