STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (c) OF LOK SABHA STARRED QUESTION NO. \*43 DUE FOR ANSWER ON 20.07.2022, RAISED BY SHRI PARTHIBAN S.R. REGARDING APPAREL PARK

(a) to (c): Eight Textile Parks under the Scheme for Integrated Textile Park (SITP), have been sanctioned by the Government in the State of Tamil Nadu with a proposed project cost of Rs. 732.89 Crore, having GoI share of Rs. 259.66 Crore. The detailed status of the textile parks is annexed.

Apart from this, the Union Cabinet has approved setting up of 7 PM Mega Integrated Textile Regions and Apparel (PM MITRA) Parks across the country with a total budgetary outlay of Rs. 4,445 Crore. Under the scheme, 18 proposals from 13 State Governments including State of Tamil Nadu have been received.
