COVID-19 CARE HOSPITALS IN CHHATTISGARH

1028. SHRIMATI GOMATI SAI:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the total number of COVID-19 care hospitals setup in Raigarh and Jashpur districts of Chhattisgarh through financial assistance provided by the Union Government along with their bed capacities;
- (b) the per head expenditure being incurred on bed and food facilities being provided to patients per day; and
- (c) the estimated per head expenditure incurred towards the complete treatment of such patients in these hospitals?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (c): The Union Government has approved funds of Rs. 109.8 Crores under **Emergency Response and Health Systems Preparedness Package-I** (ECRP-I) for the State of Chhattisgarh.

Additionally, the Union Government has approved funds of Rs. 626.6 Crores under **Emergency Response and Health Systems Preparedness Package – II (ECRP-II)** for the State of Chhattisgarh to establish District Paediatric Units (including Oxygen Supported beds and ICU beds), increase the availability of ICU beds in Government health facilities, maintain buffer stock of essential medicines required for effective COVID management, in addition to provision for required drugs and diagnostics.

Under ECRP-II, fund provided for District Raigarh, was Rs. 42.42 Crores and for District Jashpur was Rs. 22.40 Crores. Component wise details of support provided to Raigarh and Jashpur, as per NHM PMS portal, are placed at Annexure-I and Annexure –II respectively.

As per information received from State Government, the per head expenditure incurred on bed and food facilities provided to patients per day in COVID-19 care hospitals in Raigarh district was Rs. 397.7/- and in Jashpur district was Rs. 150/-.

The estimated per head expenditure incurred towards the complete treatment of such patients in these hospitals in Raigarh is Rs. 3977/- and in Jashpur district is Rs. 6495/-.
