Will the Minister of AYUSH be pleased to state:

- (a) whether the Government has introduced any Ayush wellness centers in India;
- (b) if so, the details thereof, State/UT-wise particularly in North Eastern States and tribal districts in India; and
- (c) the details of the fund released and utilized for such wellness center?

ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) to (c): The Ministry of Ayush has approved the operationalization of 12,500 AYUSH Health and Wellness Centres (HWCs) through State/UT Governments as a component of the Centrally Sponsored Scheme of National AYUSH Mission (NAM) in a phased manner by the year 2023-24. Under NAM, as per the proposals received from different State/UT Governments through State Annual Action Plans (SAAPs), the Ministry of Ayush has approved 7553 AYUSH Health and Wellness Centres (AHWCs) for operationalization across the country including the North Eastern States and tribal districts in India from the year 2019-20 to 2021-22. The State/UT wise detail of AYUSH HWCs approved units, funds released and utilized is furnished in **Annexure**.
