Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the steps taken by the Government for opening of small Industrial Training Institutes (ITI) and technical education in various part of the country particularly in the Scheduled Castes and Scheduled Tribes dominated areas;
- (b) if so, the details thereof; and
- (c) the details of funds allocated / utilized under various heads for setting up of ITIs in the country State/UT-wise including Jharkhand?

(a) to (b) Setting up of Industrial Training Institutes (ITIs) and its operation are in the domain of respective State Governments, whereas preparation of norms and designing curricula along with conducting examination and certification are the responsibility of Central Government. The Government has relaxed guidelines to setup Multi Skill Training Institutes (MSTIs) in unserved blocks with minimum one trade and no restriction on minimum land requirement. Also, it is decided to allow Government Secondary and Senior Secondary or Local body Schools in unserved block to open ITI and run Craftsman Training Scheme (CTS) courses in their premises with relaxed affiliation norms. Moreover, there is a network of more than 14,000 Industrial Training Institutes (ITIs) across India. The detail of ITIs functioning across the country including Scheduled Castes and Scheduled Tribes dominated areas is given at Annexure -I.

c) Central Government is providing financial assistance to State Governments for establishment of ITIs under two schemes, namely, "Skill Development in 48 Districts affected by LWE" and, "Enhancing Skill Development Infrastructure in NE States". The details of coverage and fund released, including the State of Jharkhand, under the above two schemes are given at Annexure-II and Annexure-III respectively.
