**QUESTION**

**1204. SHRI NABA KUMAR SARANIA:**

**Will the Minister of CORPORATE AFFAIRS**

**be pleased to state:**

- (a) the details of the Scheduled Tribes owned companies registered in the country;**
- (b) the amount of CSR fund spent by them during the last five years;**
- (c) the number of companies of North-Eastern States which have spent CSR fund on different activities;**
- (d) the details of the total number of registered and at present operational companies in the country, State-wise;**
- (e) the number and names of the companies operational in the tea-garden sector and their annual income at present; and**
- (f) the amount of CSR fund spent on different activities by the different tea companies in the country during the last five years?**

**(a)and(b): Separate data for companies owned by scheduled Tribes is not maintained by Ministry of Corporate Affairs (MCA) as there is no such requirement under Companies Act, 2013.**

**(c): There are 57 companies of North-Eastern States which have spent CSR fund on different activities as per filing data upto March 2022.**
