Will the Minister of FINANCE be pleased to state:

- (a) whether the European countries have invested in India;
- (b) if so, the details of amount of investment made in various sectors during the last three years; and
- (c) the various measures being taken by the Government to boost foreign investment?

ANSWER

MINISTER OF STATE (FINANCE)

(SHRI PANKAJ CHAUDHARY)

- (a) & (b) the Government of India maintains the country-wise and sector-wise FDI data for those countries that invest in India. Statements indicating country wise FDI including "European countries" and sector-wise cumulative FDI for the last three years are at **Annexure-II** and **Annexure-II** respectively.
- (c) to promote Foreign Direct Investment (FDI), the Government has put in place an investor-friendly policy, wherein most sectors, except certain strategically important sectors, are open for 100% FDI under the automatic route. Further, the policy on FDI is reviewed on regular basis, to ensure that India remains attractive & investor friendly destination. Changes are made in the policy after having consultations with stakeholders including apex industry chambers, associations, representatives of industries/groups and other organizations. In the recent past, reforms in the FDI policy have been undertaken in sectors such as Insurance, Petroleum & Natural Gas, Telecom etc.
