INFRASTRUCTURE DEVELOMENT IN TRIBAL AREAS

1224. SHRIMATI POONAM MAHAJAN: MS. DEBASREE CHAUDHURI:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the strategies or action-plans by the Government for the infrastructural development of tribal hamlets across the country;
- (b) whether the tribal hamlets are provided health related infrastructural development to fight against Covid pandemic;
- (c) if so, the details thereof and if not, the reasons therefor;
- (d) the utilization of the funds allotted to the NGOs working for the welfare of Scheduled Tribes, strengthening education among Scheduled Tribe girls in low literacy districts and other schemes and programmes being implemented for the welfare of the tribal people; and
- (e) the details of the data for the last five years?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA)

(a): Tribal Sub-Plan (TSP)/Scheduled Tribe Component (STC)/Development action Plan for STs (DAPSTs) is a dedicated source of fund for tribal development. TSP is a multi-pronged strategy which includes support for education, health, sanitation, water supply, livelihood etc. Major part of infrastructure development in tribal dominated areas and provision of basic amenities to tribal people in the country is carried out through various schemes / programmes of concerned Central Ministries/Departments and the State Governments concerned, while the Ministry of Tribal Affairs (MoTA) provides additive to these initiatives by way of plugging gaps. Apart from the schemes and interventions of Ministry of Tribal Affairs, 40 Central Ministries / Departments have been mandated to earmark STC funds in the range of 4.3 to 17.5 percent of their total Scheme allocation every year for tribal development. State Governments are also supposed to earmark TSP funds in proportion to ST population (Census 2011) in the State with respect to total State Plan.

Further Government has revamped the existing Scheme of 'Special Central Assistance to Tribal Sub-Scheme (SCA to TSS) with nomenclature 'Pradhan Mantri Adi Adarsh Gram Yojna (PMAAGY)', which aims at providing basic infrastructure in 36428 villages with significant tribal population having at least 50% tribal population and 500 STs in a span of five years. The scheme envisages to mitigate gaps in various sectors of development including health and economic well-being through appropriate convergence of resources available under various schemes of Central and State Governments. The State-wise list of number of villages identified under the Scheme is at **Annexure 1**.

- (b) & (c): "Public Health and Hospitals" being a State subject, the primary responsibility of strengthening public healthcare system including for the tribal communities lies with the respective State Governments. However, Ministry of Health and Family Welfare through the National Health Mission (NHM) and other schemes, provides financial and technical support to States/UTs to strengthen their health care systems as also to address health situations arising out of Covid pandemic including setting-up/upgrading public health facilities and augmenting health human resource on contractual basis for provision of equitable, affordable healthcare to all its citizens particularly the poor and vulnerable population including tribal population based on requirements placed by the States in their Programme Implementation Plans (PIPs). Details of funds provided by Ministry of Health and Family Welfare to the States as Scheduled Tribe component during 2020-21 and 2021-22 is Annexure 2. Details of funds provided by the Ministry of Tribal Affairs to the states during 2020-21 and 2021-22 under different schemes to address health related issues as per proposals received from them are at Annexure 3.
- (d) & (e): The funds released under the schemes/programmes of Ministry of Tribal Affairs including the NGOs working for the welfare of Scheduled Tribes, strengthening education among Scheduled Tribe girls in Low Literacy Districts during last three financial years are given at Annexure 4.
