- (a) the details of total Goods and Services Tax (GST) collection amount for the years 2019-2020, 2020-2021, 2021-2022 in compensation fund; and
- (b) the details of amount given to the States from this compensation fund, State-wise?

(a): Details of net Goods and Services Tax (GST) compensation cess collected into Consolidated Fund of India (CFI) for the years 2019-20, 2020-21, 2021-22 are shown in the Table. The Cess so collected into CFI would be transferred to the GST Compensation Fund and utilised for the payment of compensation to the States/UTs as below:-

(b): State-wise details of GST compensation released to the States from compensation fund during the years 2019-20, 2020-21 & 2021-22 are as per **Annexure-I**. In addition, Centre had released Rs.1,10,208 crore in FY 2020-21 and Rs.1,59,000 crore in FY 2021-22 as back to back loan to States/UTs in lieu of GST compensation. Details are given in the **Annexure-II**.
