TOURISM PROJECTS UNDER SDS IN BIHAR

1284. SHRI PRADEEP KUMAR SINGH:

Will the Minister of TOURISM be pleased to state:

- (a) the details of the projects undertaken under the Swadesh Drashan Scheme so far, State-wise;
- (b) the present status of work on these projects; and
- (c) the steps taken by the Government for time-bound completion of work on the ongoing projects particularly in Bihar?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (c): The details of the projects sanctioned in various States under Swadesh Darshan Scheme (SDS) along with their status is annexed.

The Ministry of Tourism has taken various steps to monitor progress and time-bound completion of the SDS projects sanctioned in the country including Bihar. The steps taken in this direction include the following:-

- I. The Ministry of Tourism holds regular review meetings with the State Governments/Union Territory Administrations/Implementing Agencies to monitor progress of ongoing projects.
- II. Completion timelines are fixed for implementing agencies to complete the projects.
- III. Directions have been issued that all the State Governments/UT Administrations/Implementing Agencies must complete the projects sanctioned under Swadesh

Darshan scheme within the approved timelines failing which expenditure incurred on the works undertaken beyond the completion timelines will have to be borne by the respective State Governments/UT Administrations /Implementing Agencies.

- IV. The Ministry of Tourism has issued instructions that new projects under Swadesh Darshan scheme 2.0 will not be sanctioned to the States/UTs, which fail in successful completion of the already sanctioned projects.
- V. The Ministry of Tourism has also developed a dashboard for updating project status including physical & financial progress, on real time basis, by the Implementing Agencies.
