1352. SHRIDHARMENDRA KASHYAP:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the details of activities undertaken by the Government using its share of the Compensatory Afforestation Fund Management and Planning Authority funds under the Compensatory Afforestation Fund Act, 2016, since the year 2018; and
- (b) whether any initiatives were undertaken by the Government in the State of Uttar Pradesh by using these funds since the year 2018 and if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI ASHWINI KUMAR CHOUBEY)

(a) The Compensatory Afforestation Fund Management and Planning Authority (CAMPA) funds are being utilized as per provision of Compensatory Afforestation Fund Act, 2016 and Compensatory Afforestation Rules, 2018 for compensating the loss of forest & tree cover, ecological services and hydrological regime due to diversion of forest land for developmental projects through various afforestation activities, control of forest fire, soil and moisture conservation activities, and forest & wildlife protection activities.

The Central Government utilises its share of CAMPA Fund(National Fund) for forest and wildlife related research and studies, schemes/ programmes on recovery of endangered species and implementation of specific schemes like Nagar Van Yojana, School Nursery Yojana, monitoring and evaluation works of CAMPA activities carried out by States/ UTs, office expenses of National CAMPA Authority etc. So far, total 23 schemes/ projects have been approved for implementation from National Fund, out of these 5 projects were approved prior to 2018. The details of schemes/projects taken up under National Fund are enclosed in Annexure-I.

(b) As per information received from Government of Uttar Pradesh various activities undertaken from State CAMPA fund include compensatory afforestation, artificial regeneration, assisted natural regeneration, soil & moisture conservation works in forests, protection of forest, forest fire prevention and control operations, improvement of wildlife habitat, biodiversity conservation, construction of residential and office building for frontline staff, research and development, information technology and communication for the protection of forest and wildlife,

publicity and public awareness programme. The details of State CAMPA fund utilised by Government of Uttar Pradesh for undertaking various activities since the year 2018 are mentioned at Annexure-II.
