- (a) whether the Government is contemplating to increase the number of Tribes India outlets to provide market to the handicrafts produced by tribal people and natural products;
- (b) if so, the details of the number of the Tribes India outlets State-wise across the country State-wise including Uttar Pradesh; and
- (c) the budget allocated to these manufacturers for the purpose of purchase during the last three years and the details of the business at these outlets, State-wise?

- (a) & (b): As informed by Tribal Co-operative Marketing Federation of India (TRIFED), opening of TRIBES India Outlets is a continuous process and it is opened as and when felt necessary depending on the local market requirements.
