Funda Allocated under PMMSY

1463. **SHRI AJAY KUMAR MANDAL:**

Will the Minister of **FISHERIES, ANIMAL HUSBANDRY AND DAIRYING** मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) the funds allocated to the States particularly to Assam and Bihar under the Pradhan Mantri Matsya Sampada Yojana (PMMSY), State-wise during the last three years and the current year;
- (b) the details of funds sanctioned, allocated and utilized under PMMSY during the last three years and the current year, State and district-wise including the States of Assam and Bihar;
- (c) the details of targets set under this and the status of implementation of PMMSY in the above mentioned States, district-wise including Bhagalpur district and achievements made so far alongwith its positive response;
- (d) whether achievement made up to the set targets and , if so, the details thereof and if not, the steps being taken by the Government to achieve the targets;
- (e) whether fish production has increased in Bhagalpur district under PMMSY, if so, the details thereof and if not, the reasons therefor; and
- (f) the funds allocated under the Fisheries and Aquaculture Infrastructure Development Fund to Bihar, district-wise including Bhagalpur district during the said period?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING:

(SHRI PARSHOTTAM RUPALA)

(a) and (b): The Pradhan Mantri Matsya Sampada Yojana (PMMSY) with an investment of Rs.20,050 crore in the fisheries sector has commenced with effect from the Financial Year (FY) 2020-21. The state-wise details of the projects approved, central funds sanctioned, released and utilized including to the Government of Assam and Bihar during last two years of implementation of PMMSY i.e. 2020-21 and 2021-22 are furnished at Annexure-I. District wise funds allocated and utilized during the year 2020-21 as reported by Government of Assam and Bihar are furnished at Annexure-II and Annexure-III respectively.

(c) to (e): Under PMMSY, Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying has set targets of an additional fish production of 2 lakh tonne for the Government of Assam and 3 lakh tonne for the Government of Bihar during the period of five years from 2020-21 to 2024-25. The Government of Assam has reported increasing trend in fish production from 3.73 lakh tonne in 2019-20 to 4.17 lakh tonne in the year 2021-22. Similarly, fish production in the State of Bihar has also increased from 6.41 lakh tonne in 2019-20 to 7.62 lakh tonne in 2021-22. The Government of Bihar has reported that the fish production in Bhagalpur district has increased from 0.14 lakh tonne in 2019-20 to 0.18 lakh tonnes during 2021-22.

(f): In order to address the infrastructure requirement for fisheries sector, since 2018-19, the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, is implementing a dedicated fund namely Fisheries and Aquaculture Infrastructure Development Fund (FIDF) with a total funds size of Rs. 7522.48 crore. FIDF provides concessional finance to the Eligible Entities (EEs), including State Governments/Union Territories and State entities for development of identified fisheries infrastructure facilities through Nodal Loaning Entities (NLEs) namely (i) National Bank for Agriculture and Rural Development (NABARD), (ii) National Cooperatives Development Corporation (NCDC) and (iii) All scheduled Banks. Under the FIDF, the Department of Fisheries provides interest subvention up to 3% per annum on the loans availed by the eligible entities from the Nodal Loaning Entities (NLEs) for the identified fisheries projects. The Government of Bihar has not submitted any proposal for availing the benefits under the Fisheries and Aquaculture Infrastructure Development Fund for development of fisheries infrastructure.
