- (a) whether the Government has published the State Business Reform Action Plan-2020 (SBRAP-2020) which ranks States and Union Territories based on business environment;
- (b) if so, the details thereof;
- (c) whether the State of Kerala has improved its position compared to SBRAP-2018 and 2019 in Ease of Doing Business (EoB) index and if so, the details thereof;
- (d) whether the Government intends to provide special financial assistance to the States which are in the forefront of EoB index; and
- (e) if so, the details thereof and if not, the reasons therefor?

(a) & (b): Yes, Sir. Department for Promotion of Industry and Internal Trade (DPIIT) has released assessment of States and Union Territories (UTs) under Business Reforms Action Plan, 2020 on 30.06.2022.

BRAP, 2020 included 301 reform points covering 15 business regulatory areas such as Investment Enablers, Access to Information and Transparency, Online Single Window System, Land Administration and Transfer of Land and Property, Land Allotment, Construction Permits Enablers, Labour Regulation Enablers, Environment Registration Enablers, Inspection Enablers, Paying Taxes, Obtaining Utility Permits, Contract Enforcement and other sector specific reforms. States and UTs have been assessed based on their performance in implementation of these reforms. Based on the assessment, States and UTs have been categorized as Top Achievers, Achievers, Aspirers and Emerging

Business Ecosystems. The assessment under BRAP, 2020 is given at **Annexure**.

Yes, Sir. Kerala has improved its performance over the last 3 editions of BRAP exercise, although, the assessment methodology adopted in these editions of the BRAP are different from one another. The performance of Kerala over the last 3 editions of BRAP exercise is depicted below:
